Important Notes on Tuition

Registration and Tuition

The Registration Fee is due at the time of registration. It is paid only one time, one fee per student/family for the entire school year. The Registration Fee is non-refundable. There is no waiver for the registration fee when paying by semester. A student is not registered unless there is a completed application with the registration fee. The Application MUST BE sent to the Ballet Mississippi office. Teachers DO NOT accept Registrations and Fees.

Tuition is billed August through May, excluding December. Full month tuition is charged for August to cover the classes that meet through December.

There is a sibling discount of 15% for each additional student. The discount is taken off the lowest tuition rate.

Balances paid by auto pay and bank draft need to be processed the first of the month through the bank, not the Ballet Mississippi office.

Balances paid by certified check are due the 10th of the month and no later than the 10th. Late fees will be incurred after the 10th of the month.

Debit, bank draft or credit card authorization returned for insufficient funds incur a \$25 transaction fee.

Ballet Mississippi accepts the following types of payment: Bank draft, Certified Check, MasterCard, Visa and American Express.

No refunds are given for classes missed because of illness, injury, vacation or weather. Make-up classes will be schedule for cancellations due to weather or other situations not within our control.

Any student who takes even one class in a month must pay for the entire month. Classes are not pro-rated.

Production Fees

Production fees apply for students participating in *The Nutcracker* (Due October 1st) & Spring Performances (Due February 1st). If you do not plan to participate in the spring performance, you must notify the office by January 1, 2014. Otherwise, you will be responsible for the spring production fee.

Students are not allowed into rehearsal if the production fees are not paid by the due date. Students will forfeit their roles if the production fees are not paid.

For any student withdrawing from the Ballet Mississippi School, the parents must notify the Ballet Mississippi Office in writing (email is acceptable) if the student intends to stop taking classes. The student continues to accrue tuition and production fee charges until the Ballet Mississippi Office has been notified.
